Netjets International		AFA filed cards on 11/5/09 for representation election at NJI, Inc. (Case No. R-7225). The NMB determined on 5/12/10 that it is not a single carrier for purposes of representation with Netjets (NJA). NJA is represented by the IBT. The NMB has scheduled the Notice and Sample Instructions to be sent out on 6/17/10. The voting period will be from 6/17 - 7/14/10. Tally will take place on 7/14/10 at 2:00 p.m. EDT.
